2010 – present. Distinguished Professor *Emeritus*, School of Social Work, University of North Carolina at Chapel Hill

1993 – 2009. Wallace H. Kuralt, Sr., Professor of Public Welfare Policy and Administration

Taught research methods applied to the evaluation of social interventions. Externally funded research and technical assistance activities involved the analysis of public policies and programs affecting disadvantaged individuals and families, and the assessment of systems that provide family supports and services. Served as principal investigator for evaluations of multi-jurisdictional initiatives to improve outcomes for families and children. Worked with state and local policymakers and program managers to develop evaluation capabilities in public agencies and nonprofit organizations serving families and children.

Responsible for managing multidisciplinary staff of approximately 30 social science researchers and support staff whose principal focus was the evaluation of social and health programs. Designed and implemented quasi-experimental and fully randomized evaluations of human service demonstration projects.
